NEEDS

- a. Guidance and management with FDA in order to produce safety educators and become PSA Trainers or PSA Lead Trainers, but in Spanish language. The main concern of food safety coordinators in Mexico is that the final test is in English language and for them are difficult to write and to express their own thoughts in that language. For that reason, if FDA provide a final test, but translated to Spanish language, It could be easier to produce more safety educators that provide training to our growers.
- b. Support of Packager-Exporters of avocado in Mexico in order to drive on growers to FSMA implementation on field. The PSA growers training course is one way to satisfy the FSMA Produce Safety Rule requirement and it must be the main condition or requirement to buy the avocado fruit to growers on field.
